**SPACKMAN ENTERTAINMENT GROUP TO LIST ON CATALIST BOARD OF SGX-ST**

- ***Lodges Preliminary Offer Document with SGX Catalodge***
- ***First Korean film production group to list in Singapore***

***Singapore, June 26, 2014*** – Spackman Entertainment Group Limited (“Spackman Entertainment Group” or the “Company” and together with its subsidiaries, the “Group”), one of Korea’s leading theatrical film production groups, has lodged its preliminary offer document in connection with its proposed initial public offering and listing on the Catalist board (“Catalist”) of the Singapore Exchange Securities Trading Limited (“SGX-ST”).

The Group primarily produces, presents and invests in theatrical films. The Company’s two wholly-owned film production subsidiaries, namely, Zip Cinema and Opus Pictures, are two of the most recognised film production labels in Korea and have produced some of Korea’s most commercially successful theatrical films in the past seven years. Zip Cinema has produced and released eight films, and Opus Pictures has produced and released seven films, making a combined total of 15 films. Since becoming part of the Group in January 2012, Zip Cinema has released two films: *COLD EYES* (2013) and *ALL ABOUT MY WIFE* (2012) (co-produced with Soo Film) and Opus Pictures has released three films: *FOR THE EMPEROR* (2014), *SNOWPIERCER* (2013) (co-produced with Moho Film) and *HOWLING* (2012) (co-produced with Film Poeta).

Zip Cinema's back-to-back releases of comedy/romance/drama film *ALL ABOUT MY WIFE* and crime/thriller film *COLD EYES*, were among Korea's top 10 grossing movies of 2012 and 2013, respectively. *ALL ABOUT MY WIFE* featured Lim Soo-jung, Lee Sun-kyun and Ryou Seung-ryong, while *COLD EYES* starred Seol Kyung-gu, Jung Woo-sung, Han Hyo-joo and Lee Jun-ho.

Opus Pictures' co-production of critically-acclaimed sci-fi/action film *SNOWPIERCER* was Korea's number two film of 2013 (in terms of box office ticket admissions) and is also the 10th best Korean film in history in terms of ticket admissions in Korea. The film was made in English and directed by world-renowned Korean director, Bong Joon-ho, featuring Chris Evans (*Captain America*), John Hurt (*Harry Potter*) and Academy Award winners, Tilda Swinton (*Michael Clayton*), and Octavia Spencer (*The Help*), while also headlining Korean stars, Song Kang-ho and Go Ah-sung. Distribution rights for *SNOWPIERCER* have been sold in over 100 countries, and the film is slated to be released in the United States on 27 June 2014.

On 11 June 2014, Opus Pictures released crime/action film *FOR THE EMPEROR* in Korea.

The Group currently has a total of seven Korean film projects in development, pre-production, or production: two films are scheduled to be released by the end of 2014, while three films are currently in development and scheduled to be released in 2015. Another two films are currently in development and scheduled to be released in 2016.

The Group also selectively distributes foreign films in Korea.

Secondarily to the Group's core film business, it also:

- makes investments into entertainment companies and film funds that can financially and strategically complement its existing core operations;
- operates a café-lounge called *Upper West*, in the Gangnam district of Seoul; and
- produces documentary programmes for broadcast and cable television.

PrimePartners Corporate Finance Pte. Ltd. is the Issue Manager, Sponsor and Placement Agent of the proposed initial public offering and the Listing.
